

2006 Achievements

- Applied for and received Safe Routes to Schools Grant.
- Completed River Road culvert replacement.
- Completed Pilon Road culvert replacement.
- Installed paved recreation path, backstops, and other amenities
- Initiated revision of Zoning Bylaws and Subdivision Regulations
- Commissioned a feasibility study for expansion of the wastewater treatment facility

2006 Achievements - continued

- Initiated process to identify additional water source for municipal water system
- Issued 178 Permits and 39 Certificates of Compliance
- Development Review Board held 56 public meetings and reviewed 14 new subdivision projects
- Began feasibility study for additional sidewalks in the growth center
- Completed first ever independent annual audit by a CPA (AM PEISCH)

2007 Anticipated Projects

- Continue working on Safe Routes to Schools related projects.
- Continue Joint meetings with School Board regarding long range planning initiatives
- Complete all work and installation at the recreation park.
- Hold public meetings reviewing revised Zoning Bylaws and Subdivision Regulations; and approve them.
- Acquire a "downtown" designation for the village of Fairfax.

2007 Anticipated Projects continued

- Complete feasibility study for expansion of the wastewater treatment facility, and determine implementation costs.
- Continue attempts to identify additional water source for municipal water system
- Complete feasibility study for additional sidewalks in the growth center

Fiscal Pressures

- Law enforcement is now a budgeted line item (\$77,000.00)
- Heath Insurance increased 12% for 2007 (\$8500.00)
- Socials services with direct impact to Fairfax residents is now a budgeted line item (\$9337.00)
- Increased cost of petroleum based products and steel.
